- Iraqi Refugee Family Gains Permanent Residency
An Iraqi family no longer felt it was safe to remain in their home country because of their religious beliefs. After facing years of persecution, imprisonment, and even torture, the family's patriarch earned his education and sought visas for his family, hoping to find work in the United States. The family applied for and received asylum, but hoped to earn permanent residency in the country. The process involved completing applications for each of the five family members and gathering hundreds of pages of supporting documentation.
