Copyright infringement action under the fair use doctrine related to the HathiTrust Digital Library (HDL), a digital preservation repository that provides long-term preservation and access services for public domain and in copyright content from a variety of sources, including Google, the Internet Archive, Microsoft, and in-house partner institution initiatives. HathiTrust is a partnership of many major academic research libraries, including the Library of Congress, the New York Public Library, the Ivy League universities, Johns Hopkins University, the Massachusetts Institute of Technology, Stanford University, the University of Michigan, and Michigan State University. Ms. Kornfield represented a group of university trustees and boards of regents as amici curiae in this matter: The Board of Trustees of the University of Illinois, the Board of Trustees of Michigan State University,

the Regents of the University Minnesota, the Board of Regents of the University of Nebraska, Northwestern University, The Pennsylvania State University, and the Trustees of Purdue University.
