Governor Whitmer Signs Executive Directive 2020-08 to Aid with Enforcement of Coronavirus Restrictions

On August 4, 2020, citing concern about slowing progress in the State's efforts to suppress the spread of COVID-19, Governor Whitmer issued Executive Directive 2020-08. This directive establishes guidelines for State departments to ensure compliance with previous COVID-19 related Executive Orders. Specifically, Executive Directive 2020-08 requires State departments to immediately take the following steps:

Evaluating Resource Allocation

• State department directors and autonomous agency heads must review budget allocations to make enforcement of COVID-19 orders laws a priority. Special focus should be given to enforcement at establishments where COVID-19 spread has been common.

Enforcement

- Departments and agencies must consider violations of COVID-19 orders to be presumptive evidence of a "public health hazard" or "imminent and substantial hazard to the public health."
- The Department of State Police must enforce violations of COVID-19 orders as they would any other violation of law.
- When the Department of Agriculture and Rural Development determines that a food establishment has violated a COVID-19 order, the director must consider whether to order the establishment to immediately cease operations.
- Departments and agencies should coordinate enforcement efforts to increase efficiency.

Licensing

- There are several new directives that apply to agencies and departments that issue licenses to individuals or businesses that offer services to the public:
 - Agencies and departments should consider violations of COVID-19 orders as evidence of a lack of suitability for licensing.
 - Where there is a credible complaint that a licensee has violated a COVID-19 order, the department or agency must refer the complaint to all relevant licensing authorities.



 If an agency or department becomes aware that a business has violated a COVID-19 order, they must consider whether the violation requires suspension of their license(s).
